## **Questions and Answers About These Chapters**

**Question:** Are the Judicial Council forms contained in the **Handbook** official?

**Answer:** Rule 982(e) of the California Rules of Court provides, "A party may file a duplicate of a Judicial Council legal form produced by a laser printer or similar device. The device may also print, in a contrasting typestyle equivalent to that produced by a typewriter, text that otherwise would have been entered by a typewriter or word processor." Rule 982(f) provides, "A party or attorney who files a Judicial Council legal form certifies by filing the form that it is a true and correct copy of the adopted or approved form." The forms in the **Handbook** were typeset from scratch; they are not images of photocopies. Consequently, they are not mirror images of the Judicial Council forms. For instance, the quotation marks and apostrophes in the sans serif typeface differ slightly. We have gone to great lengths to make true and correct duplicates of the Judicial Council forms. including copying the sloppy typesetting practices employed in those forms and the typographical errors. We believe that an

attorney can in good faith certify that these forms are true and correct copies of the Judicial Council forms. The possibility exists, however, that some nit-picking clerk might notice the difference and reject a form printed from the **Handbook**. (Note that the second pages of Judicial Council forms are printed upside down, to facilitate reading the form without removing it from the court file. Because a **Handbook** user, to print a Judicial Council form, must print one side of a piece of paper and then print the second side of the form on the back side of the same piece of paper, we have not printed the second pages upside down.) We elected not to use images of photocopies, though scanning the forms would have been much easier than retypesetting them, because retypesetting the forms allows a user of the **Handbook** to produce a far superior form.

**Question:** Can I order a copy of the completed chapters rather than incurring the online charges to download the files?

Answer: We do not intend to divert our attention from completing the first volume of the **Handbook** by trying to market an incomplete version ahead of time. We are willing, however, to distribute completed chapters for the nominal cost of \$20. Question: Can I order a printed copy of the completed chapters?

Answer: Paper and ink is an obsolete method for publishing legal materials. The future of legal publishing is digital. Paper gets more expensive every day. The content of the publication should change constantly, to reflect the constant changes in the law. It is not economical to print a small run of a large law book, and the storage costs are substantial. Accordingly, we are leaning towards publishing the finished <code>Handbook</code> in digital form only, unless demand for a printed version justifies the burden of creating one. We recognize, however, that reading a paper document is easier and sometimes more convenient than reading the document on a computer screen. For this reason, we have decided not to inhibit the reader's ability to print these chapters if he wishes. Be prepared, however, to use a lot of paper. The current chapters already consume 1121 pages.
