1. A copy of your wireless service agreement (contract) and a copy of the Costco order confirmation receipt must be included with each rebate coupon mailed to Stuart Lee Rebates, the rebate vendor. Please keep a copy of your rebate form for your records.
2. All rebate forms must be post-marked no later than the 30th day from the date of purchase as indicated on your Costco order confirmation receipt.
