Why You Received This Letter

The Franchise Tax Board (FTB) takes the privacy and security of your confidential information very seriously. We are providing a summary of all active Power of Attorney (POA) representatives on your account for your review. What You Need to Do

If you need to revoke one or more of the listed POA Declarations, you must take one of the following actions:

- Log in to your online MyFTB account to view, edit, or revoke your POA Declaration(s).
- Call us at 800.852.5711 and reference the associated Declaration ID number.
- Send us a completed FTB 3520 RVK, Power of Attorney Declaration Revocation.

Please do not return this letter.

If you have more than one POA or TIA relationship with an individual representative, revoking any POA or TIA relationships with that individual representative will not change their online access level for any remaining relationships. Definitions

MyFTB

FTB's online tax account information service.

Limited Online Account Access

Allows your tax professional(s) to view available notices and correspondence issued by FTB within the last 12 months in MyFTB.

Full Online Account Access

Allows your tax professional(s) to take available actions, and view your online account information, such as estimated tax payments, available notices and correspondence, balance due, and tax year details for the year(s) authorized on your POA Declaration in MyFTB.

N/A

The representative has no online access to your MyFTB account.

Year Specific

The representative has been authorized for a single year or income period.

The representative has been authorized for multiple years or income periods.

All Years

The representative has been authorized for all years or income periods.
