DEPOSIT, CANCELLATION & REFUND POLICIES:

NON-HOLIDAY TRAVEL PERIOD:

January 1 - February 18, February 27 - April 15, & April 24 - December 23, 2011
Online bookings must PAID IN FULL at time of booking and are NON-REFUNDABLE.

FOR CALL CENTER RESERVATIONS:

A NON-REFUNDABLE deposit of \$200 per person is required within 7 days of booking your reservation. Reservations must be paid in full 45 days prior to travel. If reservation is made inside 45 days of travel, reservation must be paid in full for all travel components at time of booking. Reservations become NON-REFUNDABLE after full payment and/or 45 days prior to travel.
