# **Executive Summary**

**Cloud Prime is bringing Enterprise messaging to the Cloud.** It is built on a proven application-toapplication messaging and file transfer software solution offered as SaaS, providing for 100% secure delivery of Enterprise payloads with service levels guaranteed.

### **Cloud Prime Validation**

Enterprise messaging is based on technologies which do not meet new requirements, are cost prohibitive and in some cases decades old.

- Modern fax machines became feasible in the 70's, EDI standards appeared in the 80's, VPN's were introduced in the 90's and post 2000, web-based messaging appeared.
- Legacy messaging solutions, payment processing / VAN networks, and VPN's are difficult to maintain and expensive to deploy.
- A large portion of sensitive corporate email is sent via traditional email servers without adhesion to compliance or security.
- Finally, the infrastructure cost to support SMB's with a larger enterprise oriented solution is not realistic and thus this market remains greatly under served.

### Market

Cloud Prime sits perfectly at the intersection of several large billion-dollar markets. Distributed messaging (\$10B), Payment Processing (\$20B), EDI/VAN (\$28B) and corporate email (\$4B). These are all growing markets that are looking for secure and reliable IP or cost-effective Cloud-based alternatives.

### **Cloud Prime Intellectual Property**


Cloud Prime owns significant IP including 4 patents and 4 others in process. There has been a historic investment of \$50m in the current IP portfolio.
