**Pay the corporation's debt in full. The corporation may be required to remit payment by Electronic Funds Transfer (EFT).** Go to [ftb.ca.gov](http://ftb.ca.gov) and search for EFT. Once a corporation remits an estimated payment or extension payment over \$20,000 or its total tax liability exceeds \$80,000 for any taxable year beginning on or after January 1, 1995, it must make all future payments, regardless of the taxable year or amount, through an electronic funds transfer. Payments made by other means will result in a penalty of 10 percent of the amount paid (R&TC Section 19011). If the corporation is not required to pay by electronic funds transfer, enclose the above part of this notice and mail it with a check or money order for the total amount due payable to the Franchise Tax Board. Write the corporation's name and account number on the payment. **Use the enclosed return envelope and mail to: FRANCHISE TAX BOARD, PO BOX 3065, RANCHO CORDOVA, CA 95741-3065.** No additional penalties or interest accrue on the existing liability if we receive full payment within 15 days of the notice date.
